

PRIVACY POLICY

GENERAL STATEMENT

The web site you have entered is operated by or on behalf of Recoiless Technologies International Corp Limited ACN(092 154 857) ("RTI").

RTI is committed to protecting your personal privacy. This Privacy Policy outlines the type of information that is collected by RTI on this website, and how we use and protect it. This Policy tells you what to do if you do not want your Personal Information collected when you visit our website, and how you can change information you have already provided to us. This Policy applies only to this website. For example, it does not apply to banners, sweepstakes and other advertisements or promotions we may sponsor or participate in on websites owned by third parties.

YOUR CONSENT TO THIS PRIVACY POLICY

By using our website, you say that you agree with the terms of our current Privacy Policy as posted in this area of our site. If you do not agree with any term in this Policy, please do not use the site.

COLLECTION OF PRIVATE INFORMATION

As used in this Privacy Policy, 'Personal Information' means personally identifiable, information such as your name, street address, screen name, email address and telephone number.

Throughout our site, you may be asked to provide Personal Information so that we may contact you, fill out a survey, make a comment or enquiry or for a variety of other reasons. Please be assured that RTI will not collect any Personal Information unless you provide this information voluntarily.

When you provide us with Personal Information, you are authorising us to use that information in accordance with the terms of this Privacy Policy, which includes your right to limit our use of the Personal Information (see 'Who to Contact' below).

OTHER INFORMATION WE MAY COLLECT

You may have heard of "cookies," which are files or pieces of information that may be stored in your computer's hard drive when you visit a website. RTI may use cookies to collect other information during your visit to our website, such as the particular site areas you visit and the products or services you buy through our website. We collect this information to better tailor our site and our products to your interests and needs. Cookies may also be used to help speed up your future activities at our site. For example, a site can recognise that you have provided Personal Information to use and refrain from requesting the same information a second time. Most browsers are initially set to accept a cookie. If you'd prefer you can set yours to refuse cookies or to alert you when cookies are being sent. Refusal of cookies at the site you enter may result in an inability to visit certain areas of the site or to receive personalised information when you visit the site.

In addition we are constantly trying to improve how we promote our website. To help us do this, we may measure the effectiveness of our web presence by determining when you clicked on to get to our site. Site measurement statistics may be used to personalise your website experience, as well as to evaluate – anonymously and in the aggregate – statistics about usage of the website. Information about your computer, such as your IP address (a number assigned to your computer whenever you surf the Internet), the type of Internet browser you are using and the type of operating system you are using may also be collected and linked to your Personal Information. This is to ensure that our website presents the best web experience for visitors, and that they are effective information resources.

Some of the pages you visit may also collect information through the use of pixel tags (also called clear gifs) that may be shared with third parties which directly support RTI's promotional activities and website development. For example, website usage information about visitors to our web sites may be shared with our third party advertising agency in order to better target Internet banner advertisements on RTI websites. The information collected through the use of these pixel tags is not, however, personally identifiable, although it could be linked to your Personal Information.

Finally, we may supplement the information that you provided us with other information we hold or that we receive from third parties. We do this for marketing purposes in order to provide more targeted products and service to meet your needs.

HOW WE USE YOUR INFORMATION

Your Personal Information and the information we gather about your visits to our websites are used solely by RTI for the express purpose for which it was collected (eg to respond to your enquiry). It may also be used by us to improve our websites, and to contact you regarding changes to the RTI or services and offerings that may be provided by RTI now or at some time in the future. We may also share it with or pass it to other companies related to or associated with RTI. At any time, however, you may opt out of such future contact. (See "Who to Contact" below)

At times we may retain third parties to process and analyse data we collect on our websites, including Personal Information, solely to help us improve our products and our web sites.

Finally, please note that we will release your Personal Information if required to do so by law, or by search warrant, subpoena or court order.

SECURITY OF INFORMATION

We take reasonable precautions to keep your Personal Information secure. Access to your Personal Information is permitted among our employees only on a need-to-know basis.

CHANGES IN OUR POLICY

RTI reserves the right to change or remove this Privacy Policy at our discretion. If we decide to change our Privacy Policy we will post those changes here. We encourage you to visit this area frequently to stay informed.
